

The relative strengths and weaknesses of Bauunternehmung Hermann GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bauunternehmung Hermann GmbH compared to the market average is the variable Due After More Than1 Year, increasing the Economic Capital Ratio by 271% points. The greatest weakness of Bauunternehmung Hermann GmbH is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 494% points.

The company's Economic Capital Ratio, given in the ranking table, is 271%, being 21% points above the market average of 250%.
