

The greatest strength of Weberhaus GmbH Co KG compared to the market average is the variable Due After More Than1 Year, increasing the Economic Capital Ratio by 290% points. The greatest weakness of Weberhaus GmbH Co KG is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 545% points.

The company's Economic Capital Ratio, given in the ranking table, is 290%, being 40% points above the market average of 250%.
