

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Due After More Than1 Year, increasing the Economic Capital Ratio by 222% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Liabilities To Banks, reducing the Economic Capital Ratio by 372% points.

The company's Economic Capital Ratio, given in the ranking table, is 222%, being 28% points below the market average of 250%.
