

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 93% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Due Within1 Year, reducing the Economic Capital Ratio by 47% points.

The company's Economic Capital Ratio, given in the ranking table, is 281%, being 26% points above the market average of 255%.
