The greatest strength of Goldbeck GmbH Konzern compared to the market average is the variable Bank Balances And Cheques, increasing the Economic Capital Ratio by 111% points. The greatest weakness of Goldbeck GmbH Konzern is the variable Net Income Remainder, reducing the Economic Capital Ratio by 232% points.

The company's Economic Capital Ratio, given in the ranking table, is 111%, being 144% points below the market average of 255%.
