

The relative strengths and weaknesses of Pfeiffer GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Pfeiffer GmbH Konzern compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 75% points. The greatest weakness of Pfeiffer GmbH Konzern is the variable Due Within1 Year, reducing the Economic Capital Ratio by 42% points.

The company's Economic Capital Ratio, given in the ranking table, is 258%, being 3,0% points above the market average of 255%.
