

#### Tell Bau GmbH Rank 41 of 116

The relative strengths and weaknesses of Tell Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Tell Bau GmbH compared to the market average is the variable Work In Progress, increasing the Economic Capital Ratio by 48% points. The greatest weakness of Tell Bau GmbH is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 47% points.

The company's Economic Capital Ratio, given in the ranking table, is 279%, being 14% points above the market average of 265%.
