

Cadolto Modulbau GmbH Rank 90 of 113

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 198% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Liabilities, reducing the Economic Capital Ratio by 185% points.

The company's Economic Capital Ratio, given in the ranking table, is 198%, being 197% points below the market average of 395%.
