

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 239% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Liabilities, reducing the Economic Capital Ratio by 164% points.

The company's Economic Capital Ratio, given in the ranking table, is 239%, being 157% points below the market average of 395%.
