

The greatest strength of Baugesellschaft Walter Hellmich GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 17% points. The greatest weakness of Baugesellschaft Walter Hellmich GmbH is the variable Liabilities To Other Long Term Investees And Investors, reducing the Economic Capital Ratio by 19% points.

The company's Economic Capital Ratio, given in the ranking table, is 252%, being 0,86% points below the market average of 253%.
