

The greatest weakness of Moser GmbH Co KG is the variable Prepayments Received On Account Of Orders Deducted From Assets On The Face Of The Balance Sheet, reducing the Economic Capital Ratio by 788% points.

The company's Economic Capital Ratio, given in the ranking table, is 0,0000041%, being 253% points below the market average of 253%.
