

The greatest strength of Florack Bauunternehmung GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Florack Bauunternehmung GmbH is the variable Due After More Than1 Year, reducing the Economic Capital Ratio by 166% points.

The company's Economic Capital Ratio, given in the ranking table, is 269%, being 8,0% points below the market average of 277%.
