

### Dreßler Bau GmbH Rank 59 of 110

The relative strengths and weaknesses of Dreßler Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dreßler Bau GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Dreßler Bau GmbH is the variable Due After More Than 1 Year, reducing the Economic Capital Ratio by 160% points.

The company's Economic Capital Ratio, given in the ranking table, is 263%, being 14% points below the market average of 277%.
