

#### Knobel BAU GmbH Rank 81 of 110

The relative strengths and weaknesses of Knobel BAU GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Knobel BAU GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 78% points. The greatest weakness of Knobel BAU GmbH is the variable Due After More Than 1 Year, reducing the Economic Capital Ratio by 130% points.

The company's Economic Capital Ratio, given in the ranking table, is 230%, being 47% points below the market average of 277%.
