

The relative strengths and weaknesses of Arlt Bauunternehmen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Arlt Bauunternehmen GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Arlt Bauunternehmen GmbH is the variable Due After More Than1 Year, reducing the Economic Capital Ratio by 181% points.

The company's Economic Capital Ratio, given in the ranking table, is 283%, being 5,9% points above the market average of 277%.
