


Bauunternehmung Albert Weil Aktiengesellschaft Rank 66 of 110

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 81% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Due After More Than1 Year, reducing the Economic Capital Ratio by 154% points.

The company's Economic Capital Ratio, given in the ranking table, is 257%, being 20% points below the market average of 277%.
