

Schrobsdorff Holding AG Rank 45 of 110

The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Schrobsdorff Holding AG is the variable Due After More Than1 Year, reducing the Economic Capital Ratio by 163% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 11% points below the market average of 277%.
