

Rensch Haus GmbH Rank 20 of 110

The relative strengths and weaknesses of Rensch Haus GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Rensch Haus GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 86% points. The greatest weakness of Rensch Haus GmbH is the variable Due After More Than 1 Year, reducing the Economic Capital Ratio by 189% points.

The company's Economic Capital Ratio, given in the ranking table, is 289%, being 12% points above the market average of 277%.
