

#### Stuckert Wohnbau Aktiengesellschaft Rank 28 of 110

The relative strengths and weaknesses of Stuckert Wohnbau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Stuckert Wohnbau Aktiengesellschaft compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Stuckert Wohnbau Aktiengesellschaft is the variable Due After More Than1 Year, reducing the Economic Capital Ratio by 175% points.

The company's Economic Capital Ratio, given in the ranking table, is 278%, being 0,44% points above the market average of 277%.
