

Hanova Wohnen GmbH Rank 78 of 110

The relative strengths and weaknesses of Hanova Wohnen GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Wohnen GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 64% points. The greatest weakness of Hanova Wohnen GmbH is the variable Due After More Than1 Year, reducing the Economic Capital Ratio by 142% points.

The company's Economic Capital Ratio, given in the ranking table, is 245%, being 33% points below the market average of 277%.
