

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 58% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Due After More Than 1 Year, reducing the Economic Capital Ratio by 125% points.

The company's Economic Capital Ratio, given in the ranking table, is 222%, being 55% points below the market average of 277%.
