

The greatest strength of HBG Bau GmbH compared to the market average is the variable Liabilities, increasing the Economic Capital Ratio by 29% points. The greatest weakness of HBG Bau GmbH is the variable Due Within1 Year, reducing the Economic Capital Ratio by 1.980% points.

The company's Economic Capital Ratio, given in the ranking table, is 29%, being 217% points below the market average of 247%.
