

The greatest strength of Bickhardt Bau Aktiengesellschaft Konzern compared to the market average is the variable Buildings On Third Party Land, increasing the Economic Capital Ratio by 15% points. The greatest weakness of Bickhardt Bau Aktiengesellschaft Konzern is the variable Liabilities Remainder, reducing the Economic Capital Ratio by 36% points.

The company's Economic Capital Ratio, given in the ranking table, is 204%, being 43% points below the market average of 247%.
