

#### Haas Fertigbau GmbH Rank 5 of 116

The relative strengths and weaknesses of Haas Fertigbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Haas Fertigbau GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 141% points. The greatest weakness of Haas Fertigbau GmbH is the variable Long Term Financial Assets Remainder, reducing the Economic Capital Ratio by 96% points.

The company's Economic Capital Ratio, given in the ranking table, is 350%, being 74% points above the market average of 276%.
