

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Payments On Account, reducing the Economic Capital Ratio by 36% points.

The company's Economic Capital Ratio, given in the ranking table, is 265%, being 11% points below the market average of 276%.
