







#### Cadolto Modulbau GmbH Rank 94 of 116

The relative strengths and weaknesses of Cadolto Modulbau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Cadolto Modulbau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Cadolto Modulbau GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 88% points.

The company's Economic Capital Ratio, given in the ranking table, is 206%, being 70% points below the market average of 276%.
