

#### Schrobsdorff Holding AG Rank 43 of 109

The relative strengths and weaknesses of Schrobsdorff Holding AG are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Holding AG compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 27% points. The greatest weakness of Schrobsdorff Holding AG is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 31% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 0,20% points above the market average of 266%.
