

Markgraf Familien

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Intangible Fixed Assets, increasing the Economic Capital Ratio by 1.498% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Long Term Securities, reducing the Economic Capital Ratio by 8.676% points.

The company's Economic Capital Ratio, given in the ranking table, is 1.498%, being 1.232% points above the market average of 266%.
