

Goldbeck GmbH Rank 36 of 43

The relative strengths and weaknesses of Goldbeck GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH compared to the market average is the variable Long Term Financial Assets, increasing the Economic Capital Ratio by 56% points. The greatest weakness of Goldbeck GmbH is the variable Stockholders Equity, reducing the Economic Capital Ratio by 55% points.

The company's Economic Capital Ratio, given in the ranking table, is 166%, being 91% points below the market average of 257%.
