

The relative strengths and weaknesses of Dreßler Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Dreßler Bau GmbH compared to the market average is the variable Bank Balances And Cheques, increasing the Economic Capital Ratio by 54% points. The greatest weakness of Dreßler Bau GmbH is the variable Net Income Remainder, reducing the Economic Capital Ratio by 53% points.

The company's Economic Capital Ratio, given in the ranking table, is 211%, being 42% points below the market average of 253%.
