

Goldbeck GmbH Rank 97 of 108

The relative strengths and weaknesses of Goldbeck GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Goldbeck GmbH compared to the market average is the variable Receivables From Affiliated Companies, increasing the Economic Capital Ratio by 22% points. The greatest weakness of Goldbeck GmbH is the variable Liabilities To Affiliated Companies, reducing the Economic Capital Ratio by 82% points.

The company's Economic Capital Ratio, given in the ranking table, is 129%, being 124% points below the market average of 253%.
