



The relative strengths and weaknesses of ANES Bauausführungen Berlin GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of ANES Bauausführungen Berlin GmbH compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 25% points. The greatest weakness of ANES Bauausführungen Berlin GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 17% points.

The company's Economic Capital Ratio, given in the ranking table, is 246%, being 6,9% points below the market average of 253%.
