

The greatest strength of Baugesellschaft Walter Hellmich GmbH compared to the market average is the variable Due Within1 Year, increasing the Economic Capital Ratio by 18% points. The greatest weakness of Baugesellschaft Walter Hellmich GmbH is the variable Liabilities To Other Long Term Investees And Investors, reducing the Economic Capital Ratio by 19% points.

The company's Economic Capital Ratio, given in the ranking table, is 252%, being 1,0% points below the market average of 253%.
