



The relative strengths and weaknesses of Fritz Meyer GmbH Bauunternehmung are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Fritz Meyer GmbH Bauunternehmung compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 88% points. The greatest weakness of Fritz Meyer GmbH Bauunternehmung is the variable Bank Balances And Cheques, reducing the Economic Capital Ratio by 120% points.

The company's Economic Capital Ratio, given in the ranking table, is 325%, being 72% points above the market average of 253%.
