

The relative strengths and weaknesses of Schrobsdorff Bau Aktiengesellschaft are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schrobsdorff Bau Aktiengesellschaft compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 92% points. The greatest weakness of Schrobsdorff Bau Aktiengesellschaft is the variable Due After More Than 5 Years, reducing the Economic Capital Ratio by 603% points.

The company's Economic Capital Ratio, given in the ranking table, is 308%, being 31% points above the market average of 277%.
