

VSTR AG Rodewisch Rank 84 of 110

The relative strengths and weaknesses of VSTR AG Rodewisch are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of VSTR AG Rodewisch compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of VSTR AG Rodewisch is the variable Due After More Than 5 Years, reducing the Economic Capital Ratio by 770% points.

The company's Economic Capital Ratio, given in the ranking table, is 223%, being 54% points below the market average of 277%.
