

The greatest strength of Baugesellschaft Walter Hellmich GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 82% points. The greatest weakness of Baugesellschaft Walter Hellmich GmbH is the variable Due After More Than 5 Years, reducing the Economic Capital Ratio by 466% points.

The company's Economic Capital Ratio, given in the ranking table, is 266%, being 11% points below the market average of 277%.
