

The greatest strength of Matthias Ruppert Bauunternehmen GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 80% points. The greatest weakness of Matthias Ruppert Bauunternehmen GmbH is the variable Due After More Than 5 Years, reducing the Economic Capital Ratio by 439% points.

The company's Economic Capital Ratio, given in the ranking table, is 256%, being 22% points below the market average of 277%.
