

Schmeing Bau GmbH Rank 87 of 110

The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 108% points. The greatest weakness of Schmeing Bau GmbH is the variable Due After More Than5 Years, reducing the Economic Capital Ratio by 350% points.

The company's Economic Capital Ratio, given in the ranking table, is 219%, being 58% points below the market average of 277%.
