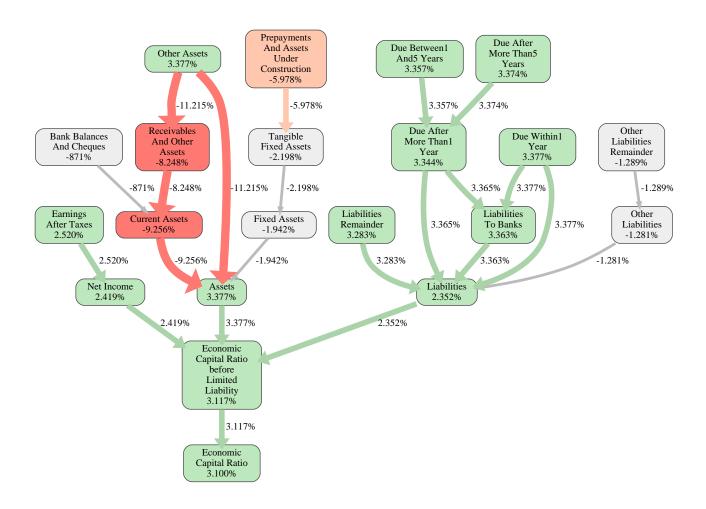

Hanova Services GmbH Rank 1 of 110

The relative strengths and weaknesses of Hanova Services GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Hanova Services GmbH compared to the market average is the variable Other Assets, increasing the Economic Capital Ratio by 3.377% points. The greatest weakness of Hanova Services GmbH is the variable Current Assets, reducing the Economic Capital Ratio by 9.256% points.

The company's Economic Capital Ratio, given in the ranking table, is 3.377%, being 3.100% points above the market average of 277%.
