The greatest strength of Bautzener Wohnungsbaugesellschaft mbH compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 84% points. The greatest weakness of Bautzener Wohnungsbaugesellschaft mbH is the variable Due After More Than 5 Years, reducing the Economic Capital Ratio by 495% points.

The company's Economic Capital Ratio, given in the ranking table, is 278%, being 0,59% points above the market average of 277%.
