

Markgraf Familien

The relative strengths and weaknesses of Markgraf Familien GmbH Konzern are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Liabilities Remainder, increasing the Economic Capital Ratio by 138% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Due Within1 Year, reducing the Economic Capital Ratio by 643% points.

The company's Economic Capital Ratio, given in the ranking table, is 318%, being 40% points above the market average of 277%.
