

Bateg GmbH Rank 66 of 115

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Stockholders Equity, increasing the Economic Capital Ratio by 30% points. The greatest weakness of Bateg GmbH is the variable Earnings After Taxes, reducing the Economic Capital Ratio by 8,4% points.

The company's Economic Capital Ratio, given in the ranking table, is 263%, being 16% points above the market average of 247%.
