

The greatest strength of Bauunternehmung Albert Weil Aktiengesellschaft compared to the market average is the variable Earnings After Taxes, increasing the Economic Capital Ratio by 98% points. The greatest weakness of Bauunternehmung Albert Weil Aktiengesellschaft is the variable Other Liabilities Remainder, reducing the Economic Capital Ratio by 73% points.

The company's Economic Capital Ratio, given in the ranking table, is 258%, being 10% points above the market average of 247%.
