

The greatest strength of Markgraf Familien GmbH Konzern compared to the market average is the variable Fixed Assets, increasing the Economic Capital Ratio by 488% points. The greatest weakness of Markgraf Familien GmbH Konzern is the variable Assets, reducing the Economic Capital Ratio by 12.835% points.

The company's Economic Capital Ratio, given in the ranking table, is 488%, being 240% points above the market average of 247%.
