

The greatest strength of Ruben Schäfer Bauunternehmung GmbH compared to the market average is the variable Net Income, increasing the Economic Capital Ratio by 97% points. The greatest weakness of Ruben Schäfer Bauunternehmung GmbH is the variable Payments On Account, reducing the Economic Capital Ratio by 51% points.

The company's Economic Capital Ratio, given in the ranking table, is 307%, being 28% points above the market average of 279%.
