

Bateg GmbH Rank 71 of 116

The relative strengths and weaknesses of Bateg GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Bateg GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 90% points. The greatest weakness of Bateg GmbH is the variable Payments On Account, reducing the Economic Capital Ratio by 33% points.

The company's Economic Capital Ratio, given in the ranking table, is 258%, being 21% points below the market average of 279%.
