

### Wadle Bauunternehmung GmbH Rank 99 of 116

The relative strengths and weaknesses of Wadle Bauunternehmung GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Wadle Bauunternehmung GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 85% points. The greatest weakness of Wadle Bauunternehmung GmbH is the variable Liabilities To Affiliated Companies, reducing the Economic Capital Ratio by 56% points.

The company's Economic Capital Ratio, given in the ranking table, is 195%, being 84% points below the market average of 279%.
