

Schmeing Bau GmbH Rank 88 of 116

The relative strengths and weaknesses of Schmeing Bau GmbH are analyzed with respect to the market average, including all of its competitors. We analyzed all variables having an effect on the Economic Capital Ratio.

The greatest strength of Schmeing Bau GmbH compared to the market average is the variable Net Income Remainder, increasing the Economic Capital Ratio by 95% points. The greatest weakness of Schmeing Bau GmbH is the variable Payments Received On Account Of Orders, reducing the Economic Capital Ratio by 28% points.

The company's Economic Capital Ratio, given in the ranking table, is 238%, being 41% points below the market average of 279%.
