

The greatest strength of HBG Bau GmbH compared to the market average is the variable Due Within1 Year, increasing the Economic Capital Ratio by 20% points. The greatest weakness of HBG Bau GmbH is the variable Stockholders Equity, reducing the Economic Capital Ratio by 89% points.

The company's Economic Capital Ratio, given in the ranking table, is 20%, being 259% points below the market average of 279%.
